ALL EXEMPTIONS MUST BE RECEIVED BY THE ASSESSOR'S OFFICE BY TAXABLE STATUS DATE OF MARCH 1st.

- 1. BASIC STAR EXEMPTION If you own a one, two or three family residence and it is your primary residence, you qualify for Basic STAR Exemption. You must file application with the New York State Tax Department online at www.tax.ny.gov or calling 518-457-2036
- 2. ENHANCED STAR EXEMPTION if you own a one, two or three family residence and it is your primary residence, AND you will be at least 65 years of age as of December 31 AND you have a basic star on your property before 2015 you may call the Assessor's office at 518-797-9265. If you do not have a basic STAR or you are a new owner you must go online at www.tax.ny.gov to register with the New York State Tax Department or call 518-457-2036 this exemption must be renewed every year.
- 3. SENIOR WITH LIMITED INCOME EXEMPTION If you own a one, two or three family residence and it is your primary residence, AND you will be at least 65 years of age as of December 31, 2015 you MAY qualify for the Senior with Limited Income Exemption. This exemption has a limited income you must meet in order to qualify. Please call the Assessor's office for information. You must file application Form RP-467 that can be obtained at the Assessor's office 518-797-9265 or online at www.tax.ny.gov This exemption must be renewed every year.
- 4. VETERAN'S EXEMPTION If you own a one, two or three family residence and it is your primary residence, AND you are a veteran or an un-remarried surviving spouse of a veteran, you may be qualified by a Veteran's Exemption. There are additional combat and disability exemptions as well, if qualified. You must file application Alternate Vet Form RP-458a or Cold War Veterans RP-458b that can be obtained at the Assessor's office or online at www.tax.ny.gov
- 5. PERSONS WITH DISABILITIES AND LIMITED INCOME If you own a one, two or three family residence and it is your primary residence, AND have a physical or mental impairment which limits your ability to engage in one or more major life activities you MAY qualify for the Persons with Disabilities and Limited Income Exemption. This exemption has a limited income you must meet in order to qualify. Please call the Assessor's office for information. A resident may not receive both the Senior with Limited Income Exemption and the Persons with Disabilities and Limited Income Exemption. You must file application Form RP-459-C that can be obtained at the Assessor's office 518-797-9265 or online at www.tax.ny.gov This exemption must be renewed every year.
- 6. AGRICULTURAL EXEMPTION these exemptions provide benefits to farm property located inside or outside of an agricultural district. Please visit www.tax.ny.gov to find out which exemptions apply to you. For more information on these and other Exemptions, please visit www.tax.ny.gov.
