BE IT FURTHER RESOLVED that the Board hold a public hearing on said proposed local law at the Town Hall, 933 County Route 401, Westerlo, New York at _____ pm on _____, 2021;

BE IT FURTHER RESOLVED that the Clerk publish or cause to be published a public notice in the official newspaper of the Town of Westerlo of said public hearing at least five (5) days prior thereto;

BE IT FURTHER RESOLVED that the Town Supervisor or his designee is authorized to prepare the Environmental Assessment Form under the State Environmental Quality Review Act, and its implementing regulations;
